# PRESIDENT'S REPORT:

A copy of the 2022 WVOTA Annual Budget was provided. Casey to complete the budget after conference/membership renewals are updated.

Proposal to increase the conference fees from \$500 to \$750. Brought forward on the 2023 budget.

The AOTF fund was discussed. President/Mary is in contact with AOTF, but Jacob was contacted by someone else and will follow up.

The conference expense budget is to be increased to \$3500.

Clarification of change of financial management of State Tax Exempt fee, Newsletter/stamps fee will be changing to Miscellaneous line item.

Credit card expense – checking and card fees at \$500+ with an estimated 700+. Casey to talk to the bank for negotiation of fees.

Memberclicks/website fees were discussed. Memberclicks is possibly transferring to a sister company. Follow-up with Memberclicks has thus far received no feedback on website issues. Discussion of removal of redundant line items.

Motion made by Jacob to approve the final budget; Casey seconded. Budget passed.

### VICE PRESIDENT'S REPORT:

Conference update discussion about possible sites for next year. Morgantown was suggested. A student initiative to increase membership was discussed. Discussed conference cost management including venue fees to help cut costs.

Motion made to have 2023 at WVU in Morgantown. Unanimous voting.

### TREASURER'S REPORT:

Memberclicks cost increased by a 5% yearly fee. Final Report to be sent. Discussion ensued. Casey and Jacob to run an audit with the bank and report back to Board on the status of funds available.

### **SECRETARY'S REPORT:**

-Traci Turley will submit the meeting minutes to President Hurt/VP Jacob Greenfield and will send them to BOD members upon completion.

### **COMMITTEE CHAIR REPORTS:**

- 1. LEGISLATIVE COMMITTEE Mary Hager State Hill Day will be on February 14, 2023. Please put money into the budget for pens or similar items for 2023 State Hill Day. This year the cost was 147.63.
- 2. MEMBERSHIP COMMITTEE Jackie Hurt 163 people on the membership roster, 63 active, 37 lapsed, 100 prospects after conference eliminates prospect as a choice. Proposed 37 lapsed, send an invoice, and set time frame, remove from membership base. And prospects to register.
- 3. CONFERENCE COMMITTEE Jacob Greenfield Jacob reported 87 registered over 100 total, mostly students, including vendors.
